LIFE **Rotationally Molded Spa Shell & Cabinet: LIFETIME WARRANTY parts & labor**
Durasport Spas/Strong™ Spas warrants the integrity of the spa's cabinet structure will not rot, crack, or peel, as a result of defects in material or workmanship to the original retail purchaser, as long as the original customer owns the spa. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

2 **Plumbing & Equipment: 2 year parts**
Durasport Spas/Strong™ Spas warrants the integrity of the spa's plumbing against leaks as a result of defects in material or workmanship for a period of 2 years on parts and 1 year on labor to the original retail purchaser. Durasport Spas/Strong™ Spas warrants the integrity of the spa's Equipment (Pump, gauges, heater, and control system) to be free from defects in material and workmanship for a period of 2 years on parts and 1 year on labor from the date of the original retail purchase to the original retail purchaser. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

1 **Replacement Only: 1 year**
Durasport Spas/Strong™ Spas warrants the integrity of the spa's accessories (where applicable): Including jet inserts, pillows, and standard spa cover for one year, to the original retail purchaser. This warranty does NOT cover damage due to abuse, vandalism, or acts of nature.

Warranty Specifics

- **Ozonators:** Durasport Spas/Strong™ Spas warrants that the factory installed ozonator will not malfunction due to defects in material or workmanship for a period of 1 year from the date of the original retail purchase.
- **LED Lighting:** Durasport Spas/Strong™ Spas warrants that the factory installed LED Lighting System will be free from defects in materials and workmanship for a period of 1 year from the date of the original retail purchase.
- **Sound System:** Durasport Spas/Strong™ Spas warrants that the factory installed Sound System will be free from defects in material and workmanship for a period of 1 year from the date of the original retail purchase. There is a 90-day labor warranty on Sound System.

Please Note: Electrical Connections must be made by a qualified, licensed residential electrician. Improper installations present hazards which can result in personal injury or property damage and void the warranty on the spa. Please see the Pre-delivery Guide and/or Owner's Manual for additional information.

IMPORTANT: Strong™ Spas' Warranty is void if the spa is moved to any location that is not the original consumer address.

Exclusions

This limited warranty is enforceable only by the original retail purchaser. Fuses, covers, light bulbs, light lenses, seals on pump and motor, and any dealer installed accessories are specifically excluded from this limited warranty.

All warranties are null and void if any of the following occur:

- The spa has been subject to alteration, neglect, misuse or abuse.
- Any damages caused by failure to install, maintain, and operate the spa in accordance with the recommendations contained in Durasport Spas/Strong™ Spas Owner's Manual.
- Any and all costs of spa's removal and replacement including but not limited to removal and transportation, damages to landscaping, and/or house structures.
- The spa has been used in a non-residential application or an application in which it was not designed.
- Spa shell damage caused by a failure to cover the spa while empty of water and/or exposure to direct sunlight.
- Any damages caused by improper maintenance of spa water chemistry or by any undesignated spa chemicals which may cause bleaching of the spa shell and erosion or deterioration of stainless jets.
- The use of Tru-Chlor or calcium-hypochlorite
- Any repairs that are done by any one other than authorized Durasport Spas/Strong™ Spas agent, or anyone without express written permission by Durasport Spas/Strong™ Spas warranty department.
- Any and all costs associated with obtaining warranty service. Durasport Spas/Strong™ Spas is not responsible for any form of Trip Charge required by a service provider.
- Do not use third-party well-based systems in your spa! Damage caused by well-based systems that have not been factory installed will not be covered under warranty.
